

**INVITATION****2 October 2023****Online [Webex]****14.00-16.10 CEST****Stakeholders' consultation meeting on:****EU - Greenland Strategic Partnership on sustainable raw materials value chains**

The Government of Greenland through the Ministry of Mineral Resources and Justice has exchanged with Executive Vice-President Maroš Šefčovič, confirming a mutual interest in developing a strategic partnership on raw material value chains.

In line with this agreement, the EU and Greenland wish to expand their cooperation, based on a future *Memorandum of understanding between the European Union and the Government of Greenland on a strategic partnership on sustainable raw materials value chains*.

This Partnership would build on 5 pillars:

1. Economic and industrial integration of value chains for critical and other raw materials.
2. Cooperation to leverage high international environmental, social and governance (ESG) standards.
3. Deployment of infrastructure for raw materials value chains.
4. Strengthen capacities and skills development along raw materials value chains.
5. Cooperation on research and innovation for prospecting, exploration, extraction, processing, refining of raw materials and supporting areas.

In view of the establishment of this Partnership, we would like to invite you to a dedicated stakeholders' consultation meeting. The meeting will bring together relevant stakeholders from the EU and Greenland, with the aim of identifying together cooperation opportunities in the raw materials sectors.

Prior to the meeting, we will share a draft Roadmap for the Partnership, which is intended to operationalise the Partnership by identifying concrete actions and involvement from Greenland and EU side. We invite you to share your view on the proposal and make proposals for activities that should be included. We would welcome such feedback at the end of the meeting and in writing after the meeting.

In addition to this meeting, we will investigate the possibilities of setting up B2B, B2G and G2G matchmaking events, and will get back to you with more information at a later stage.
